A RESOLUTION DULY ADOPTED BY THE BUSINESS COMMITTEE OF THE KICKAPOO TRIBE OF OKLAHOMA APROVING, ADOPTING, AND CERTIFYING THE ENACTMENT OF *THE KICKAPOO TRIBE OF OKLAHOMA CRIMINAL ORDINANCE SUB-CHAPTER B(2)-SEXUAL ABUSE* APPROVED BY GENERAL COUNCIL ON FEBRUARY 26, 2011

WHEREAS, the Kickapoo Tribe of Oklahoma is a Federally recognized Native American government entity pursuant to the *Thomas-Rogers Oklahoma Indian Welfare Act of June 26, 1936, (49 Stat. 1967)*; and

WHEREAS, the Business Committee of the Kickapoo Tribe of Oklahoma is authorized to speak and act on behalf of the Tribe in accordance with the *Kickapoo Tribe of Oklahoma Constitution and By-Laws, Article V, Section 1(a)*; and

WHEREAS, the Kickapoo people have, through a continuation of Kickapoo history, an organized self-government, since time immemorial, sovereign powers inherent in Kickapoo tradition and recognized by treaties with the government of the United States of America and in the Constitution of the United States of America; and

WHEREAS, the General Council of the Kickapoo Tribe of Oklahoma is the supreme governing body of the Tribe pursuant to the *Kickapoo Tribe of Oklahoma Constitution and By-Laws, Article IV, Section 1*; and

WHEREAS, the General Council of the Kickapoo Tribe of Oklahoma has the authority to enact and amend Ordinances pursuant to the *Kickapoo Tribe of Oklahoma Constitution and By-Laws, Article IV, Section 2*; and

WHEREAS, a Special General Council Meeting was duly called and conducted on February 26, 2011; and

WHEREAS, the Business Committee approves, adopts and certifies the enactment of the *Kickapoo Tribe of Oklahoma Criminal Ordinance Sub-Chapter B(2)-Sexual Abuse* which was approved by General Council on February 26, 2011 with votes of 35 in favor, 0 opposed, and 1 abstention.
